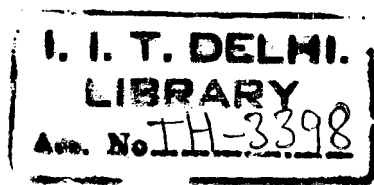

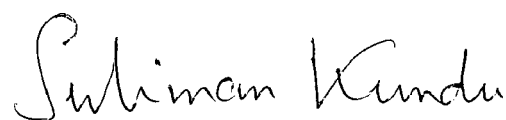

Abstract

This thesis studies the pseudocompact-open topology on $C(X)$, the set of all continuous real-valued functions defined on a Tychonoff space X and the corresponding dual space.

The space $C_{ps}(X)$ denotes the topological space $C(X)$ equipped with the pseudocompact-open topology. After having a few basic results on $C_{ps}(X)$, we compare the pseudocompact-open topology on $C(X)$ with the well-known topologies on $C(X)$ such as the point-open topology, the compact-open topology and the topology of uniform convergence on $C(X)$. Then we study the following topological properties of $C_{ps}(X)$ in terms of the topological properties of X :

- (i) submetrizability and metrizability,
- (ii) various kinds of completeness properties such as uniform completeness, complete metrizability, Čech-completeness, almost Čech-completeness, local Čech-completeness, sieve-completeness, partition-completeness, pseudocompleteness and the property of being a Baire space, and
- (iii) various countability properties such as separability, countable chain condition, Lindelöf property and second countability.

Since $C_{ps}(X)$ is a locally convex space, naturally this thesis also studies its dual space, that is, the space of all continuous linear functionals on $C_{ps}(X)$. This dual

space is denoted by $\Lambda_{ps}(X)$ which inherits a natural norm from a larger Banach space. We study the natural question of the completeness of this norm on $\Lambda_{ps}(X)$ as well as a compatible lattice structure on it. Since continuous functions and Baire measures on Tychonoff spaces are linked by the process of integration, it is very natural to identify an element of $\Lambda_{ps}(X)$ with a suitable measure on X . So finally we study the measure-theoretic characterization of $\Lambda_{ps}(X)$.
